

Chief Pride Mandatory Uniform Dress Code

Students are expected to dress appropriately and positively represent Miami Carol City Senior High School. It is our expectation that all students that are enrolled at Miami Carol City Senior High School will adhere to the Mandatory Uniform Dress Code.

Shirt

- Polo Shirts (Collar) – Solid Orange, Black or White, or any approved MCC vendor shirt
- Button Down/Collar Dress Casual Shirts - Orange, Black, White or Khaki
- Spirit Shirts, Class or Club T-Shirts are permitted on Fridays only!
- Student ID (Lanyard worn around the neck)

Pants

- Pants - Black or Khaki
- Black Jeans are permitted on Fridays only!

Shoes

- Sneakers or closed toe shoes

The following items have been mutually agreed upon by the students, teachers, parents, administrators and community partners in Miami Carol City Senior High School
EESAC to be **inappropriate**:

1. Caps, hats, visors, scullies, do-rags, bandanas, stocking caps, hair wraps, headwear, hair rollers, scarves and/or hoods or any head attire that conceals identity. This policy item does not apply to headgear considered as a part of religious or cultural dress.
2. Sun glasses or “shades” are not to be worn on school grounds and or during a school sponsored fieldtrip, unless medical documentation is provided to support use.
3. Sagging—the wearing of one’s pants or shorts low enough to reveal undergarments or secondary layers of clothing.
4. Blouses/shirts, pants, shorts that expose a bare midriff, buttock or portions of the posterior anatomy.
5. Cut-off clothing or clothing with holes, cut outs, rips or tears.
6. Backless/strapless shoes, shoes with cleats.
7. Clothing that is excessively tight, excessively loose or transparent.
8. T-shirts or collarless shirts.
9. Clothing or accessory with derogatory/obscene/profane/vulgar /lewd/ offensive or sexually suggestive language/pictures or containing references to alcohol, drugs, tobacco, weapons, violence, gangs or bullying.
10. Any clothing or accessory determined by the staff and/or administration to distract other students/teachers from learning/teaching or to constitute a safety or health hazard to others and/or property.

Individual classes/programs may implement additional dress code restrictions based on content and/or safety to life issues.

Miami-Dade County Public Schools Board Policy 5511, effective July 1, 2011, states that...“students whose personal attire or grooming distracts the attention of other students or teachers from their school work shall be required to make necessary alterations before entering the classroom or be sent home by the Principal. Students who fail to meet the minimum acceptable standards of cleanliness and neatness as determined by the principal and as specified in this policy shall be subject to appropriate disciplinary measures including suspension.”
